**FOOD TRUCK / FOOD VENDOR ACKNOWLEDGMENT**

1. All vendors are responsible for bringing all necessary equipment for a full setup such as a tent, tables, chairs, serving counters, trash cans, and other supplies. If you have a tent, make sure you have weights to keep your tent secured.
2. Vendors must adhere to the setup and teardown times provided. Early breakdown or leaving before the event ends may result in being banned from future events. Load in and Load out times will be emailed to you closer to the event.
3. Vendors such as Food Trucks or Food Vendors must upload a copy of their current food permit or temporary event permit issued by the local health department. All food vendors must comply with state and local food safety regulations.
4. If you need to plug in for electricity, first reach out to us at [contact@terrorfest.net](mailto:contact@terrorfest.net). There is very limited availability for Food Trucks **only**. If you have an electricity solution we encourage you to bring it. Gas generators are not permitted.
5. Your area must be kept clean and sanitary at all times. Please monitor food temperatures, storage, and preparation conditions to ensure safety and compliance.
6. Vendors are accountable for maintaining cleanliness and tidiness in their designated areas at all times. It is imperative that all trash and waste be promptly removed from the vicinity.
7. No open flames, hazardous materials, or illegal substances are allowed.
8. Vendors must ensure their displays do not exceed their assigned space, and we request that you refrain from obstructing public walkways.
9. All food vendors must clearly display their menu and pricing.
10. Bands, music, entertainment, large speakers or PA systems are not permitted to disrupt the event's planned schedule. Amplified sound, music, or demonstrations must be kept at a volume that does not interfere with neighboring booths or the overall event.
11. Vendors shall not change or adjust equipment that is set up by the show in any room or area. Please contact a supervisor first.
12. **Our event is family friendly**, so we ask that you avoid displaying anything overly inappropriate. Any content intended for individuals 18 and older should be clearly labeled and kept out of plain sight.
13. All Vendors are required to uphold a professional demeanor when engaging with staff, attendees, guests, volunteers, and directors. Both public intoxication and any form of confrontation during the event is strictly prohibited. Any behavior considered unprofessional may result in your removal from the premises without refund.
14. Vendor fees are non-refundable unless otherwise stated in writing by Silverback Events. No-shows may affect future participation.



## **Food Vendor & Food Truck Payment Terms for TerrorFest 2025**

### ***Food Payment Structure***

Food Vendors and Food Trucks may choose:

- A flat fee payment, **or**
- A lower flat fee plus a percentage of gross sales (commission)

### **10 x 10 FOOD VENDOR SPACE**

10x10 Food Vendor: \$250 + tax/fees + 10% commission

or

10x10 Food Vendor: \$500 + tax/fees (flat fee)

### **10 x 20 FOOD VENDOR SPACE**

10x20 Food Vendor: \$350 + tax/fees + 10% commission

or

10x20 Food Vendor: \$500 + tax/fees (flat fee)

### **FOOD TRUCK**

Food Truck: \$350 + tax/fees + 10% commission

or

Food Truck: \$500 + tax/fees (flat fee)

### ***Commission Payment Requirements***

If selecting the lower flat fee plus percentage of sales:

- The full commission amount of 10% must be paid before leaving the festival
- All commission payments are due no later than 10:00 PM on October 4th, 2025

Commissions must be paid via:

- Check
- Cash
- Zelle

## Additional Notes

- Failure to pay the required commission by the deadline may result in exclusion from future events and/or additional penalties as outlined in your vendor agreement.
- Vendors are responsible for calculating and reporting their sales accurately at the end of the event.
- Receipts for all commission payments will be provided upon request.
